A late pay rate of 2.499% per month will be assessed and charged on any and all amounts past due. All accounts are due and payable at the remittance address shown on the American Energy Supply Corporation invoice, unless accompanied by specific remittance instructions; Applicant agrees that American Energy Supply Corporation is authorized to apply all unspecified payments at its discretion.
